- AUTOMATIC VERIFICATION OF THE QUALITY OF INCOMING DATA

 The Source Data Quality function allows you to verify that the data collected is compliant by analyzing the quality of each incoming event. A visual interface with weather-like indicators allows you to see the status of your incoming data at a glance. The tool also offers a complete monitoring system to quickly find out the status of the collection.
- REPROCESSING OF DATA BEFORE TRANSMISSION TO PARTNERS

 Through its Data Cleansing feature, the Commanders Act X platform allows data to be reworked or even encrypted in an automated manner before being sent to partners (e.g., by using sha-256 encryption to encrypt personal data).
- AUTOMATIC DETECTION OF ANOMALIES

 The platform offers you a global and precise vision of the proportion of events transmitted to your partners thanks to the Event Delivery function. In the event of an anomaly, you will be alerted in real time on the status of your data transmission. You can easily identify and correct the causes of errors thanks to the explanatory messages.
- GRANULAR CONTROL

 With the Event Inspector, you are able to monitor each event (inbound and outbound) specifically and inspect the details of its raw data.
- DATA STANDARDIZATION

 The Normalized Datalayer function allows you to define validation rules for the properties of each event, and thus benefit from the automatic verification of incoming data. It also allows you to label and describe each property in detail, so as to have a real shared data dictionary. This data specification, coupled with a categorization of personal data, contributes to the proper conduct of data governance.
- HARMONIZATION OF YOUR ONLINE & OFFLINE DATA

 Thanks to Identity Resolution, you are able to reconcile your online and offline data, but also cross-device, allowing you to benefit from a 360° profile view that gathers all data collected on each of your users.
- DATA ENRICHMENT
 You can enrich your data with real-time events from your product catalog, an external API, the weather or from an external file.
